Eliza: This constitution will take effect once Council has approved it on January 30th.

Michael: There will be General Meeting same as last year. Every student who attends will have a vote. We can emplace eligibility requirements in our electoral regulations. This means we can make it so only those who have been involved can run for editor positions, etc.

Skanda: This will definitely go through Council?

Eliza: It's already been approved by Andrew Heath, Joel has provided him the necessary documentation. It would be shocking if the Council didn't approve it. Jason: Is it a problem for Council that the elected officers have not been elected under this democratic constitution.

Eliza: We talked to Andrew about this. He said they would be fine with it for the first year. Given that even if we did go through the process, we only had 5 nominations, we wouldn't get more under our regulations. So it would not affect the result. Andrew is under the impression that Council does not mind. It terms of legal stuff, it's transitive.

Jason: I was just concerned with the Council's take on it.

Joel: Move to a vote, re-read the motion and preamble.
