- 5.2 Motion to amend the <u>Electoral Regulations</u> as follows, to come into effect on 1 December:
 - Replace all instances of "News Editor" and "News Editors" with "Editor" and "Editors"
 - Replace all instances of "Digital Editor" and "Digital Editors" with "Visual Content Executive" and "Visual Content Executives"
 - Replace all instances of "Editorial Board" with "Editorial Committee"
 - Replace all instances of "Council" with "Board"

- Amend 2.8 to read as follows:
- 2.8. Number of Positions
 - 2.8.1. Unless otherwise specified in the Constitution, Policies, or Regulations, the General Meeting specified in 2.2.1 of this policy shall elect:
 - a) Three (3) Editors;
 - b) One (1) Executive for every Team apart from the Editorial Team; and
 - c) One (1) Secretary.
- 2.8.2. The Council may, from time to time, decide to increase the number of Editors and/or Executives.
- 2.8.3. This decision must be made by unanimous vote.
- 2.8.4. Where such a decision has been made, the Council Chair or Secretary must promulgate the decision within one (1) week, and call a General Meeting to be held within four (4) weeks of the decision.
- 2.8.5. This General Meeting shall elect the Editor(s) and/or Executive(s) in accordance with ss 2.1-2.7 of this policy, unless:
 - a) A member has submitted to the Arbitration Panel that such an increase in the number of Editors or Executives should not occur, and
 - b) The Arbitration Panel has agreed with this submission.
- 2.8.6 If the created position(s) is/are not contested, and no submission is made and upheld under section 2.8.5, then the position will be automatically filled at the scheduled time of the general meeting. This is regardless of quorum and other procedural requirements.

Jason: I used to be in Observer,I was a reporter, then a News Editor and then a Council Member. Then I was a secretary and I had interpretive power over the constitution. It prepared me quite well. This year I was in Clubs Council as a Secretary which is an interpretive role... you can read my interpretation register from that. Arbitration deals with Honoraria. My complaint with Arbitration is that people on the arbitration panel did not fully understand how Observer operates, I do but I'm far enough removed not to have significant conflicts of interest.

Jess: I was a reporter last year and Editor afterwards. I had enough time and distance from the team, have a clean slate starting next year, I have strong views about honoraria, especially how to make it easier for reporters to submit.

Michael: I set up the Observer with Eliza back in the old days. I was Chair from 2017-2018-ish, helped write regulations and set up policies. I've been away from the organisation for about a year and half now. I don't know really anyone on the team, at least in a personal capacity. It gives me the kind of distance to be able to make calls, having the knowledge of how the news team works but also distance from the team prepares me quite well.

Kevin: (not in attendance)

Part of the ANUSA committee, but unable to attend because he is in another meeting.

Questions

Skanda: All of you have previous experience, spoke about benefits, do you have any previous working relationships with anyone on the team? Would your involvement in Observer bias you in disputes, if complaint of reporting incorrectly?

Michael: I worked with Kon and Adelle but I don't share my secrets with them. I don't know any of these people who run it now, part of the purpose of setting up Observer was about editorial standards, more about doing the job well than the institution.

Jess: Closest working relationship with people continuing next year, emotionally attached to Observer? (yes) I'm not the type of person to tow the party line, rigorous standards, not a person who will get emotionally involved.

Jason: Worked with Kon and I was in Council with him. Adelle was on my team. I wouldn't pretend that's a bias I'd be able to escape, I would recuse if related directly to someone I would know, I love Observer, I am very attached to it, but my mentality is to be critical of things that I like so that they stay good.

Ebe: Personal relationships you would like to declare among the nominees?

Jess: Michael's my partner. I make my own decisions, need to be 100% happy that it is my decision. Jason has known us for a while and would be good at recognising if that is problematic.

Jason: I'm friends with these two... personal relationships in governing bodies is not a new thing in Observer, it's just something to manage, it can be problematic at times... I think if you are aware of it, you can manage it. Iif you think you can't (you should recuse).

Michael: Who are the other members? Eliza: It is Jack Crawford and Fred

Michael: I know those people [currently on the panel]... they are both fine. Echo what Jess said.. Relationship between people on arbitration is less important than relationships between people on the panel and in the team...

Ebe: Question for incoming treasurer- why?

Kon: I experienced the ssaf process for the first time this year ... I want to stick with observer ...make sure that we get our stipends and our equipment budget.

Julian: While I will no longer be treasurer ... I plan to stay on to assist the incoming treasurer with his role... the role requires tutoring and training.

Brandon: At the start of 2017, I liked how there were a tonne of explainer articles... Do you think it will make a comeback?

Anthony: We've been training a lot of people this year.

Adelle: A lot of new reporters.

Eliza: That's the end of question time.

Jason: Dissent.
